(a) No licensee shall have any illegal liquor or liquor not purchased from a class 3, wholesale dealers' licensee, or a class 1, manufacturers' licensee, or a person authorized by the commission as a solicitor or representative of a manufacturer or wholesale dealer, on any portion of the licensed premises; provided that a class 2 restaurant licensee, class 5 dispenser licensee, class 12 hotel licensee and class 15 condominium licensee may allow patrons to bring wine onto the licensed premise for consumption with a meal.
