This project will allow upgrading of the County of Maui's DCFC EV charging stations at three sites that were previously a part of the JUMPsmart Maui and EVOhana programs.

These will come at a nominal cost of \$1 per concession agreement to County of Maui.

County of Maui is committed to achieving 100% clean ground transportation by 2045.

This project will allow the County to continue to offer important public EV charging as a service to the community. HECO (not the County) will be responsible for the installation and operations and maintenance of these DCFC EV charging units.
